INTRODUCTION:

The Low Income and Subsidized Child Care (LISCC) Committee of the Child Care Planning Council has prepared this guide to assist local early care and education professionals and others with information on the various types of subsidized child development programs now operating in Ventura County.

The guide includes common definitions and eligibility guidelines that pertain to the different types of subsidized programs. This guide is intended not as a “how to” document, but as a reference to what kinds of programs currently exist and what different eligibility requirements are used.

Information contained in this guide is subject to change. In view of this, we have attempted to provide contact phone numbers to the various programs if more information is needed. After June 2004, refer to the Child Care Planning Council of Ventura County website for updates to this guide:

1. Child Care Options

Type of Child Care	Examples of Programs	Description
Licensed Family Child Care	Family Child Care Home Family Child Care Network	Child care is provided in the home of the caregiver for up to eight children, depending on their ages. With an adult assistant, child care can be provided for up to 14 children. The child care provider needs to obtain a license through Department of Social Services, Community Care Licensing (CCL) division. The provider must complete a 15-hour CPR, Health and Safety, and First Aid course, no other education/training is required. The provider and any adult living in the home must have a fingerprint background check and Child Abuse Index clearance.
Center Based Child Care (Child Development Center)	Campus Child Care Early Headstart Headstart State Preschool General Child Care Migrant Child Care Latchkey Private Child Care Centers	Child Care Centers provide care for children all or part of the day for infants, toddlers, preschoolers, and school-age children. Minimum qualifications are regulated by licensing. Centers are generally licensed through Community Care Licensing. Some exemptions to licensing requirements exist.

Licensing requirements do not apply to exempt care providers. Exempt care providers can be registered with TrustLine. In –home care: parents are the employer and are required to pay taxes and worker’s compensation insurance in accordance to labor laws. It provides both part-time and full-time child care for children (0-5) of teen parents.

Stage 2: families may receive child care services when the County CalWORKs Department determines that the family’s work or approved work-readiness activity is stable or the family is transitioning off of CalWORKs cash assistance. Families may receive Stage Two for up to 24 months after leaving cash assistance. Stage 3: families may receive child care services if a family received a lump-sum diversion payment, or is a former CalWORKs job seeker who has used up Stage Two eligibility. Families must also meet income eligibility requirements.</p>
<p>Headstart/ Early Headstart</p>	<p>Headstart provides comprehensive services to primarily low-income families and prepares children to enter school ready to learn. Program options: center based, family child care and home based options Program components: parent involvement, education, health, transition, nutrition, transportation, family services Eligibility criteria: qualifying income (3)</p>
<p>Migrant Child Care</p>	<p>Child care and other comprehensive services are provided to migrant worker families or families who earn a minimum of 50% of their income from agriculture. Some programs operate a varying length, depending on the harvest season. Eligibility criteria: source of income, qualifying income (3) and need (5)</p>
<p>State Preschool Programs</p>	<p>Operating part-day, state preschool programs offer child care and other comprehensive services to low-income families. Eligibility criteria: qualifying income (3)</p>
<p>Latchkey Programs</p>	<p>Subsidized child care and development services are provided in child care centers for school age children. These services are typically provided on school campuses for children K-5th grade.</p>
<p>General Child Care and Development Programs</p>	<p>Subsidized child care and development services are provided in child care centers and sometimes family child care homes for infants through school age children. Eligibility criteria: qualifying income (3) and need (5)</p>
<p>Campus Child Development (currently not available in Ventura County)</p>	<p>Campus child development programs serve the children of students enrolled in college and offer additional comprehensive services. Funding for campus child care is provided by California Department of Education, student body fees and parent fees. Eligibility criteria: qualifying income (3) and need (5)</p>

- (1) State and federal funding for child care subsidies is not sufficient to fulfill the existing need for subsidies. Waiting lists (see also CEL) are established for families who qualify for subsidized child care, but can not find placement due to a lack of funding. Eligibility ranking requires programs to serve families with the greatest need first, independent of the length of time on a waiting list. The majority of families are the so-called “working poor”, many of which will never receive subsidized services.
- (2) Alternative Payment allows parents to use a child care provider of their choice. Providers can be licensed or license exempt, but no criteria for “quality” care is considered. Parent education needs to address the importance of quality early learning experiences and environments and should provide guidelines as to what constitutes a quality program. (see definition of quality and enclosures)
- (3) Families are ranked based on qualifying income and/or need to receive services. Lowest income = highest priority to receive subsidized services. However, lowest of the lowest income will vary by neighborhood, which presents a challenge when seeking highest-ranking families. In addition, highest-ranking families are typically transient and therefore, once placed on the waiting list, very difficult to locate after a period of time. Children placed in foster care are considered a family of one, and therefore have no income. No special funding for foster child care is available.
- (4) Approximately 30% of CalWORKs recipient families are using child care subsidies specifically funded for them. Some of the reasons for the relatively low usage are: overage children, ineligible providers, ineligible parents/guardians, confusion or frustration with contract requirements, lack of knowledge of services, and use of other available subsidies.
- (5) NEED is defined in funding terms and conditions by the funding source and varies by program. “Need” may include participation in training/education, employment, seeking employment, recipient of public assistance, Child Protective Services, homelessness, seeking permanent housing, incapacitation, or incarcerated/incompetent parent. Certain family situations may supercede income eligibility or other needs, such as CPS (Child Protective Services) cases, or children at risk as identified by a licensed professional and result in highest priority ranking for placement. In addition to need, income eligibility guidelines must be met.

Basic Income Eligibility and Family Fee Schedule

Background:

Education Code Section 8263(f) authorizes the State Superintendent of Public Instruction to establish a fee schedule for families utilizing child care and development services. This schedule applies to all child care and development services, including CalWORKs child care funded by the California Department of Education and the California Department of Social Services, with the exception of the following programs: State Preschool, Bay Area Handicapped, and Resource and Referral. Also exempt are referrals for Child Protective Services funded with State General Funds. Referrals for Child Protective Services provided with federal funding shall be charged a fee according to the attached schedule, unless the referring protective services worker recommends a waiver of the fee and the contracting agency agrees to such waiver.

Policy:

Families with incomes less than 50 percent of the State Median Income (SMI) are considered to be below the State poverty level for the child care and development programs, and no fees are assessed. Pursuant to Education Code Section 8263.1, the family income eligibility ceiling is 75 percent of SMI for all child care and development programs to which this fee schedule applies.

For alternative payment programs, fulltime care is defined as enrollment for six or more hours per day, while part-time care is enrollment for less than six hours per day.

For family child care home networks reimbursed under the Standard Reimbursement Rate (SRR) and for Center-based programs, full time care is defined as enrollment for 6.5 hours or more per day, while part-time care is enrollment for less than 6.5 hours per day.

Family Fee Schedule (September 2000)

The Family Fee Schedule is established by the California Department of Education, Child Development Division. It outlines the share of cost families pay who receive subsidized child care at an alternate payment program (APP) and center-based care if their income falls between 50% and 75% of the State Median Income. The family fee is per family, not per child.

3.2. Scholarship Eligibility Recommendations

Members of the Low Income and Subsidized Child Care Committee (LISCC), Child Care Planning Council of Ventura County, present the following recommendations when determining eligibility criteria for Neighborhoods for Learning, Early Care and Education Scholarships:

- a. Honor cultural preferences and meet the diverse needs of the population served by considering various child care and development options.
- b. Respect parental choice.
- c. Reimbursement will be paid at the Ventura County current Regional Market Rate.
- d. Families are only eligible to receive scholarships if they are not able to receive or access other subsidies and meet income guidelines. Documentation of income will be required.
- e. Families are required to show proof of residency within the NfL area. Acceptable documentation includes utility bills, driver's license, ID cards, etc. Should the family reside with other relatives, a letter from the relative stating that circumstance, accompanied by a utility bill, etc. is acceptable.
- f. Families can only select licensed family child care providers or licensed center-based programs.
- g. Priority is given to children entering Kindergarten within the following school year, without prior preschool experience.
- h. Families can be approved for part-day programs if the program is attended a minimum of two (2) days/week.
- i. Special circumstances, such as medical expenses, children with special needs, family emergencies etc., will be considered. Supporting documentation will be required.

Modeled after the Port Hueneme/South Oxnard NfL, the LISCC Committee recommends the following process:

1. The family completes the scholarship application provided by the NfL and provides the required documentation.
2. The NfL scholarship committee reviews and approves the application.
3. The family selects a provider and presents a copy of the license, the fee schedule, and a child care provider contract to the NfL scholarship committee.
4. The NfL scholarship committee offers scholarship amount.

Parents are responsible to select the best care available for their child based on quality standards. NfL's will make every effort to assist parents in choosing quality early care and education programs by providing information and materials as pertinent, including but not limited to: various brochures on how to find quality care, checklists, resource and referral agency information, etc. The LISCC Committee has developed a "Quality Counts Child Care Bag", which includes such information. The bags will be made available to NfLs in limited numbers.

3. Definition of Quality

The Child Care Planning Council of Ventura County acknowledges that good programs for young children provide both care and education. Quality reflects the child's experience and the positive feelings that occur when children are placed in appropriate settings. Quality is more than child development theories. It is a commitment to excellence.

While "quality" is a difficult concept to define, the National Association for the Education of Young Children (NAEYC) provides specific indicators. The following characteristics form the foundation of "quality" for Ventura County's children.

1. Adults show respect for children's needs and ideas. Adults listen and talk to children in caring ways.
2. Families are treated as valuable partners in the caring/education process. As such, they are treated with respect and encouraged to fully participate in the program.
3. The program reflects an understanding of child development for diverse children and families. Cultural, linguistic and special education differences are recognized. The program is individualized to meet the needs of every child.
4. Children are safe and well supervised.
5. The physical environment is safe, clean, orderly and contains a variety of stimulating toys and materials suitable to children's age and rate of development. Children may select activities and materials that interest them.
6. Adults recognize that children learn by being actively involved. A variety of play opportunities are offered.
7. Adults nurture children's emotional needs and facilitate positive social interaction.
8. Evaluations occur regularly which focus on the program's effectiveness in meeting children's and family's needs.
9. Adults facilitate the development of responsibility and problem solving skills in children through age appropriate guidance and discipline techniques.
10. Opportunity is provided to identify concerns regarding differing abilities. Resources are provided to parents and staff as needed.
11. Assessment of children's progress is ongoing, purposeful and appropriate. Evaluation is used to adapt curriculum and teaching to meet the needs of children.
12. Good working conditions are provided for the Child Development staff. Positive communication is promoted and consensus building is facilitated. Staff/providers continue their education or complete professional development activities.

4. Glossary of Terms

Alternative Payment Program (APP or AP Programs)

AP programs offer an array of child care arrangements for parents including in-home care, exempt care, family child care, and center care. These services most often take the form of a vendor payment issued monthly to a provider selected by the family. The AP program is intended to increase parental choice and accommodate the individual needs of the family. Some county welfare departments are among the contractors under this program. AP programs also administer Stage 2 and Stage 3 CalWORKs child care.

California Work Opportunity and Responsibility to Kids (CalWORKs)

CalWORKs is California's version of the Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA). Overseen by the California Department of Social Services, CalWORKs is a "work first" program that provides support services to help recipients move from welfare to work and toward self-sufficiency. CalWORKs devolves much of the responsibility and authority for operation of the program to California's 58 counties, increasing county flexibility and financial accountability.

Campus Child Development

Administered through the California Department of Education, campus child development programs are designed primarily for the children of students enrolled in college. The centers are operated by either student associations or the college administration and provide the same comprehensive services as other state child care and development programs. Funding for the centers is generated by the state, student body fees, and parent fees (not available in Ventura County!).

Centralized Eligibility List (CEL)

Agencies receiving funds for subsidized child care services, such as Child Development Resources of Ventura County, Inc. (CDR), Children's Home Society of California, state-funded preschool, general child care & development programs and some Neighborhoods for Learning have consolidated their waiting lists into one centralized eligibility list (CEL).

Families complete only one intake and eligibility application and submit it to CDR. Upon openings in any of the participating programs, agencies access the Internet-based CEL to enroll families waiting to receive services.

The CEL program in Ventura County is operated and maintained by Child Development Resources. Information about the CEL participation is available at (805) 485-7878 ext. 511 or 477.

Child Development Center

A child development center is a facility, which is usually not a family residence and is specifically designed to provide child care. A child development center may serve any number of children, but usually serves 13 or more for less than 24 consecutive hours.

Child Protective Services (CPS)

CPS is also known as Protective Services and is available through the California Department of Social Services. Children receive Child Protective Services through the local county welfare

department. Children who are abused, neglected, exploited, or children at-risk of abuse, neglect, or exploitation receive legal, medical, and social services.

In most subsidized child care programs, CPS families receive first priority when child care slots become available. The basic child/family data file contains a written referral dated within six (6) months immediately preceding the date of application for services, from a legal, medical, social service agency or emergency shelter. The written referral shall include either:

- A statement from the local county welfare department, child protective services unit, certifying that the child is receiving child protective services and that child care and development services are a necessary component of the child protective services plan, or
- A statement by legally qualified professional that the child is at risk of abuse or neglect and that child care and development services are needed to reduce or eliminate that risk, and
- The probable duration of the child protective service plan or the at-risk situation, and
- The name, address, telephone number and signature of the legally qualified professional who is making the referral.

Community Care Licensing Division (CCLD)

The Role and the functions of the California Department of Social Services (CDSS), Community Care Licensing Division (CCLD): CCLD is a regulatory program whose mission is to protect the health, welfare and safety of children and adults who reside or spend a portion of their time in out-of-home care. This is accomplished through the development and enforcement of regulations. The CCLD program consists of three distinct functions: prevention, compliance and enforcement.

Prevention is the reduction of predictable harm by screening out unqualified applicants and by providing applicants and licensed providers with information regarding the laws and regulations concerning the operation of community care facilities.

Compliance is the process which ensures that CCLD facilities are operated according to applicable laws and regulations. Compliance is maintained through facility inspections, issuing deficiency notices, and providing consultation regarding the correction of deficiencies.

Enforcement is a range of corrective actions (from civil penalties to facility closure) taken when a provider fails to protect the health and safety of individuals in care or is unwilling or unable to maintain compliance with licensing laws and regulations. As part of the evaluation process, child care facilities are evaluated to ensure facilities are in substantial compliance with licensing laws and regulations. If, during an unannounced site visit made by licensing staff, a facility is found to be out of compliance the facility is cited for violations of Title 22, Division 12 of the regulations, which is based on the Health and Safety Code. Violations are cited to protect the clients in care.

Child care centers and family child care homes in California are required to be licensed by CCLD, except in several counties which subcontract with the state. Two sets of regulations apply to child care. All programs must meet the requirements specified in Title 22 regulations.

In addition, most state-subsidized child care centers must meet education code requirements (Title 5), which set stricter adult/child ratios and staff qualifications than Title 22.

Co-Payment

A co-payment is that portion of subsidized child care expense, which is over the maximum allowable reimbursement rate. If a parent chooses a provider with rates above the maximum reimbursement rate, they must make up the difference in cost as a co-payment, payable directly to the provider.

Early Head Start (EHS)

Early Head Start is a program administered through Head Start. The program offers expanded services that seek to address the health needs of newborns and encourage better interaction between parents and infants and toddlers. EHS also targets families with certain needs such as parental substance abuse and parenting teens.

Early Start

Early Start is a statewide system of early intervention services for infants and toddlers, from birth to 36 months of age, with disabilities or at risk of developing disabilities. Services are provided in a family-centered, multidisciplinary, interagency, and community-based system.

Even Start

Even Start is a federal literacy program for children and their parents. This program integrates adult basic education with early childhood programs to break the cycle of illiteracy in families.

Exempt Care

Exempt child care is care delivered by a provider that is exempt from the Title 22 and Title 5 licensing requirements. Exempt providers are: a child's relatives, guardians, or conservators, an adult who cares for the children of only one other family besides his/her own; or schools registered with the California Department of Education (CDE).

Family Child Care (FCC) - Licensed

Family Child Care provides care for children in a family setting. When certain conditions are met, small family child care homes care for six children total or eight if two school-age children are present. Large family child care homes utilize two providers and may care for twelve children, fourteen if two school-age children are present and additional requirements are met.

Family Day Care Home Network

The Family Day Care Home Network is a cluster of family child care homes with centralized activities, which may include information and referral, group purchasing, administration, fiscal procedures, training, or other activities. Such networks may be associated with center care sites. This program is administered by the California Department of Education.

Family Fee

A family fee is a share of cost, which is paid by a family for subsidized child care and development services. Family fees are generally based on a sliding scale, which takes into account family size as well as income.

Head Start Program

Head Start, administered by the United States Department of Health and Human Services, is a comprehensive preschool program that prepares children to enter school ready to learn. Head Start combines basic skill development with health, nutrition, social services, and parental involvement in a family-centered approach. Head Start programs largely serve children from low-income families.

In-Home Care

In-Home Care refers to a child care arrangement which takes place in the home of the child being served as opposed to care received in the home of the caregiver.

Intake Eligibility

Intake eligibility is used to determine if families are eligible to receive program benefits. For most programs, at least one element of intake eligibility must be combined with at least one element of intake need for a family to receive subsidized child care and development services. Eligibility criteria may vary depending on program type and funding source.

Migrant Child Care

Migrant child care programs, administered by the Department of Education, serve children of migrant workers while their parents are at work. Migrant centers are open for varying lengths of time during the year depending on the growing/harvesting season. These programs provide the same comprehensive services as General Child Care and Development Programs.

Neighborhoods for Learning

First 5 Ventura County believes that local neighborhoods and communities can lead the way in shaping the future of their children. Parents, schools, early childhood educators, and service providers are joining together to create neighborhoods full of opportunities for kids and families. Through providing programs and services in neighborhood settings, Neighborhoods for Learning support families to raise children who are emotionally, socially, and academically ready for school.

Priority for Care

Priority for care is the order of precedence which is established to determine which of those eligible for benefits will be served first. Priorities for care are established for non-entitlement programs.

Private Child Care Centers (Non-Subsidized)

These programs may call themselves a child care center, day care center, preschool, nursery school, or day nursery. Various groups administer private child care centers, including non-profit organizations, for-profit businesses, faith-based organizations, military, and public or private sector employers.

Resource and Referral Programs (R&R)

Resource and Referral programs, funded through the California Department of Education, provide information to parents about the availability of child care, assist potential providers in the licensing process, provide direct services and coordinate community resources for the benefit of parents and local child care providers. These programs are available in all 58 counties of California. Some agencies with R&R contracts administer Alternative Payment Programs.

Special Education Preschool Program

All preschoolers with mildly handicapping conditions may receive developmental and early education opportunities. Children are served in typical child care settings, including state-subsidized child care and development programs and Head Start.

State Preschool Program

Funded by the California Department of Education (CDE), Child Development Division (CDD) and the federal government, this developmental preschool program offers comprehensive child care services, as well as social health, nutritional and psychiatric services. In the state preschool programs parental involvement is encouraged. State Preschool Programs are administered through school districts, colleges, community action agencies, and private non-profit agencies. Many programs offer bilingual services.

TrustLine

TrustLine is the California registry of in-home and license-exempt child care providers who have passed a background screening. All caregivers listed with TrustLine have been cleared through a fingerprint check of records at the Department of Justice. This means they have no disqualifying criminal convictions or substantiated child abuse reports in California. TrustLine registry is required for all license-exempt child care providers (except aunts, uncles and grandparents) paid by Alternative Payment Program contractors with State General Funds or Federal Block Grant funds. Child care payment may not be made to an exempt provider until the provider has applied for TrustLine registration.

Voucher

A payment or coupon which may be redeemed for child care services. A voucher may be used for:

- 1) Individual use in a setting selected by the parent;
- 2) Restricted use for child care only;
- 3) Lack of a prearranged contract between the agency and the provider; and
- 4) An unlimited number of providers, who, by complying with the payment agency's regulations are eligible to redeem vouchers in exchange for proof of services provided.

Appendix A – Regional Market Rate Ceilings

Pages 17-19

The Regional Market Rate (RMR) is issued by the California Department of Social Services every other year. It is used by Alternative Payment Programs to determine the maximum rate payable to providers who accept subsidized child care.

Rates are established based upon surveys of the amounts charged by local providers. Currently, the RMR allows reimbursement up to the 85th percentile (check Department of Education website for current updates: www.cde.ca.gov). Subsidized families who choose providers who charge more than the RMR maximum are responsible to make up the difference directly to the provider.

Appendix B - Admission Priorities

Pages 20-21

This chart was established by CDD in 2000 and assists subsidized programs (APP and center-based) in ranking families waiting to receive services. Families with the lowest incomes receive a higher priority and, as subsidized slots become available, are offered services first. Currently, due to limited funding, most subsidized programs are rarely able to offer slots to higher ranked families.

Appendix C - State Preschool Income Ceilings

Page 22

The state preschool income ceiling schedule was established by the CDD and lists the income limits for families using the state preschool program. Families eligible for this program do not pay a family fee.

Appendix D – Centralized Eligibility List

Pages 23-24

Agencies receiving funds for subsidized child care services, such as Child Development Resources of Ventura County, Inc. (CDR), Children’s Home Society of California, state-funded preschool, general child care & development programs and some Neighborhoods for Learning have consolidated their waiting lists into one centralized eligibility list (CEL).

Families complete only one intake and eligibility application and submit it to CDR. Upon openings in any of the participating programs, agencies access the Internet-based CEL to enroll families waiting to receive services.

The CEL program in Ventura County is operated and maintained by Child Development Resources. Information about CEL participation is available at (805) 485-7878 ext. 511 or 477. Applications are available in both English and Spanish.
